Wback produces soft rolls especially for burgers in plants in Bavaria and North Rhine-Westphalia. The company's main customers include Burger King.

The soft roll specialist founded by Peter Wendeln in the district of Unna in 2003 was acquired in 2013 by the Frankfurt holding company Halder, which now sold Wback to C.H. Guenther & Son.

C.H. Guenther & Son (CHG) was founded in 1851 by the German emigrant Carl Hilmar Guenther. The company, which has about 3,500 employees, has production facilities in the USA, Canada, Great Britain and Belgium. Last spring, the investment company Pritzker Private Capital Partners (PPC Partners) acquired the family business.
