The sale will strengthen the presence of the INTERSPORT brand on the German market. INTERSPORT is aiming for a clear growth course and future investments after the closing, which is expected to take place this year.

Sport Voswinkel, founded in 1904 and based in Dortmund, operates 50 sports stores throughout Germany. It has been a member of INTERSPORT since 1989 and an INTERSPORT subsidiary since 2003. Cisalfa Sport is the largest Italian sports retailer.
